Course Overview

This course is designed for law enforcement professionals tasked with the identification, disruption and dismantling of large scale trafficking organizations.

This two-day course has been designed based on current trends and extreme violence occurring within the border regions of Mexico and the United States. It is imperative that we arm investigators with a basic understanding of Drug Cartels and how they operate.

During this course, students will receive training to include the history, components, influence, and methods of operation in use by drug cartels today. The training will also provide investigators with basic tools that can be used to gather intelligence in furtherance of criminal investigations as they relate to drug cartels. Through an overview of drug cartels, students will become familiar with this subculture and its relationship to the vast narcotics network as well as its impact on the United States and law enforcement.

Students are required to attend both days of instruction to receive the full 16-hours of TCOLE credit.

This is a tuition **FREE** course and is open to all law enforcement officers and U.S. Military.
